Ron called the meeting to order at 6:08pm.

FVFD: Jim Waterman said the Town of Brooks is having a 4th of July parade, form up at 9am, parade starts at 10am.

Public Works: Travis Price gave update on town garage addition. Travis reported that Truck #6 needs to have the plates replaced. Steve Bennett made a motion to hire Hans for one week starting June 21st and to authorize Travis to negotiate a wage. Unanimous. Ron reported that the consultant who can help Dyann with Trio is named Amy Dunn and charges \$50/hour plus travel from home. Ron made a motion to hire Amy Dunn to help Dyann. Steve 2nd. Unanimous. Steve made a motion to authorize Dyann to cancel the credit card and set up a debit card with Camden National Bank and to add Dyann to debit card, remove Alyssa Brugger and keep Ron on the debit card. Unanimous.

Town Clerk: In regard to Beaver Ridge Abatement for 2020, Ron is going to check with the auditor how to credit abatement for 2020 taxes that have already been paid.

Ron made a motion to accept June 7th Select Board minutes and place them on file. Steve 2nd. Unanimous.
