APPROVED MINUTES/FREEDOM BOARD OF SELECTMEN April 27th 2015 BRW Abatement MEETING

CALL TO ORDER: 2:00 pm

Ron Price was moderator for the meeting.

PRESENT: Selectmen Ron Price (Chair), Ken Overlock and Steve Bennett. Also in attendance was Jackie Robbins, Erna Keller, Todd Presson (BRW), Rob Crawford (Attorney), lawyer for BRW, Ron Littlefield, Bob Gerrish, Carrie Bennett, Dave and Maryanne Bennett, Clara Alvarez, Doug Van Horn, Sallyann Hadyniak, Gunner Woods, Tim Biggs, Drew Fales, Frances Walker, Myrick Cross & Mrs Steve Bennett.

Todd Presson: Abatement request for BRW, we assume the turbines will have a 20 year life expectancy. We are also figuring based on new price to 0 in 20 years. 5% a year until 0 amount. Robert Crawford Attorney for BRW:

BRW has met with Maine Revenue

- Maine Revenue-good detail.. Hard cost + soft cost. Arrive at estimate (100% hard cost + 50% soft cost) make tax prediction
- Income Approach- to valuation
- Market value- only transaction is between identitys for financial benefits. No sales other than that
- 701A-Asset Life
- Depreciate to floor- not to go below what Maine Revenue suggest 30 % says lawyer
- wasting asset

Jackie:

- All due respect to Mike Rogers, but Maine Revenue doesn't tell the town what to do.
- Income approach was asked for but I still haven't rec'd
- Mr. Carroll told us a few times that there would be no depreciation. (Todd Presson said He shouldn't have said that he was wrong)
- I know Todd Presson has also said this to citizens at a meeting in 2009 (Todd said he doesn't recall that, he couldn't imagine saying that)
- I find it interesting for 5 years there has been no request for abtement.
- Abatement request only go back 185 days for value

• So we will only be talking about 2014

Todd:

- I asked Tom Carroll an he said that he didn't say that
- Jackie said there are atleast 5 people here in this room that can tell you different
- Todd sad If Tom said that then he said it in error, he doesn't have the authority to say that. Jackie:
- Improvements was around \$200,000 So as an assessor I decided that was an up keep.
- Houses need repairs & Maintenance

Todd:

- We talked to Maine Revenue on our own. Good production but our cost is more Jackie:
- 185 days for value as an assessor is all that we need to look at Todd:
- We don't want to be in every year, it would be nice to have something set up now

Jackie:

- Going forward you might want to talk to the selectmen
- There is no proof that you should have a reduction of 5% a year

Todd:

• Brian Jones wasn't interested in depreciation when we talked back in 2010. It should get reduced yearly over the 20 year life expectency.

Steve Bennett:

- Mr Crawford can you explain the market & value, and income and cost approach Mr. Crawford:
- Direct Cap-Out of revenue & expenses you get the net operating income
- Income Approach- gives you what the rate is

Steve Bennett:

- Sounds like a cross over to market value & income
- Income Approach- How they are performing should be in the assessed value

Mr. Crawford:

• These turbines are 6 yrs old

Mike Rogers from Maine Revenue:

- If one isn't in a TIF then they are assessed by 3% Hard Asset & 1 1/2% Soft Asset
- Energy credits for 10 years
- Energy Stimulus money up front
- Production Energy Tax Credits
- These all impact Income stream and they don't go below 70% value

Jackie:

• If they are in a TIF then Y are they depreciated differently

Mike Rogers:

- If there is a 100% TIF then there is no direct benefit to the individual tax payer
- There are confidential agreements

Todd:

- We are at 3% function after 10 years which brings us down to 70% step depreciation Mike Rogers:
- Assessment is only good for one year. There was no agreement ahead of time and selectmen

come and go. New board of assessors every year.

Ron Price:

- Asked Mike Rogers how many wind projects in the state that DO NOT have TIF's Mike Rogers:
- There are only 2 besides Freedom in the state

Todd:

• We need an abatement or a decrease in value

Jackie:

- My recommendation to the selectmen are
- No Abatements
- Work on the future & moving forward, leave the past behind
- Todd these upgrades that you did to make them quieter, was this so they could run at night and for longer amounts of time

Todd:

- NO
- We are open to reasonable equipment

Ken Overlock:

- When this came to us I asked what had changed...
- You say that Tom doesn't speak for the company
- Then in the future please send someone who does.
- That way there will be no confusion
- The 2009 meeting they say you made the comment about depreciation

Todd:

• If the comment was made by me I would of been talking about for the first year only.

Jackie:

• That was a selling point to the citizens of this town

Todd:

• Looks like we are at a stale mate

Steve Bennett:

• No not neccessarily

Ken/Steve made a motion to agree with Jackie and not go back for abatement, just move forward.

Mr Crawford-lawyer for BRW:

- We could stagger it until 2017
- Then 3% after that
- Follow a protocol

Todd Presson:

- Goal is to run until they aren't safe to run
- 20-25 year life expectency
- Either completely rebuild or tear down
- If we do a new project then we will start from scratch with permits and rebuild from the floor up
